Solid Financial Technologies, Inc., as debtor and debtor in possession (the “Debtor”), hereby objects (this “Objection”), pursuant to sections 105(a) and 502(b) of title 11 of the United States Code (the “Bankruptcy Code”), Rule 3007 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and Rule 3007-1 of the Local Rules of the United States Bankruptcy Court for the District of Delaware (the “Local Bankruptcy Rules”), to each of the filed claims listed in Exhibit A to the proposed order attached hereto as **Exhibit 1** (the “Proposed Order”) sustaining this Objection and incorporated herein by reference (collectively, the “Late Filed Claims”). In support of this Objection, the Debtor files the declaration of Brian Ayers, attached hereto as **Exhibit 2** (the “Ayers Declaration”), and respectfully represents as follows:

JURISDICTION AND VENUE

1. This Court has jurisdiction over this Objection pursuant to 28 U.S.C. §§ 157 and 1334, the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware, dated as of February 29, 2012.

2. Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

3. The statutory bases for the relief requested herein are Bankruptcy Code sections 105(a) and 502(b), Bankruptcy Rules 3007 and 9014, and Local Rule 3007-1.

4. This is a core proceeding under 28 U.S.C. § 157(b). Pursuant to Rule 9013-1(f) of the Local Rules, the Debtor consents to the entry of a final judgment or order with respect to this Objection if it is determined that the Court would lack Article III jurisdiction to enter such final order or judgment absent consent of the parties.

BACKGROUND

A. The Bankruptcy Case

5. On April 7, 2025, the Debtor filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code as a debtor defined in Bankruptcy Code section 1182(1) and elected to proceed under Subchapter V of chapter 11 of the Bankruptcy Code pursuant to the Small Business Debtor Reorganization Act, as amended.

6. On April 8, 2025, the United States Trustee appointed Jami Nimeroff, Esq., to serve as the Subchapter V trustee (the “Subchapter V Trustee”) in this chapter 11 case pursuant to Bankruptcy Code Section 1183(a). No other trustee, examiner, or official committee has been appointed in this chapter 11 case.

B. The Claims Process

7. By an order (Docket No. 20), entered April 11, 2025, this Court authorized and approved the retention of Omni Agent Solutions, Inc. (“Omni”) as the claims and noticing agent for the Debtor.

8. On April 16, 2025, the Debtor filed its Notice of Meeting of Creditors/Commencement of Case (Docket No. 28) (the “Bar Date Notice”), which established (i) June 6, 2025 as the deadline to file pre-petition claims against the Debtor (the “General Bar Date”); and (ii) October 4, 2025 as the deadline for governmental units to file pre-petition claims against the Debtor (collectively (i) and (ii), the “Initial Bar Dates”).

9. On April 16, 2025, Omni gave notice of the Initial Bar Dates by serving the Bar Date Notice on the creditor matrix. On April 24, 2025, Omni filed an Affidavit of Service (Docket No. 36) (the “Affidavit of Service”)² with respect to its mailing (via first class mail and email) of the Bar Date Notice. The Affidavit of Service identifies that, except for Tolomeo Bank International, Corp. (“Tolomeo International”), each of the claimants filing the Late Filed Claims was served with the Bar Date Notice on April 16, 2025 by email and first-class mail.

10. Despite a lack of service of the Bar Date Notice directed to Tolomeo International itself, Tolomeo International should be bound by the Bar Date Notice because Tolomeo International’s counsel was timely served with four copies of the Bar Date Notice. Specifically, Tolomeo International’s counsel, who filed Tolomeo International’s claim in this case and represents Tolomeo International in litigation underlying its claim, was timely served with a copy of the Bar Date Notice via email and first-class mail for four other parties represented by the same counsel in the underlying litigation, including Tolomeo Bank Ltd. *See* Affidavit of Service, at 3

(service on the Sanchez/LRV firm on behalf of Crossbarfx Ltd), 7 (service on the Sanchez/LRV firm on behalf of Tolomeo Bank Ltd, Vauban Bank Int'l Corp and Vauban Int'l Bank Corp).

RELIEF REQUESTED

11. After review of the Debtor's books and records, and upon review of the claims register maintained in this case, the Debtor has determined that each of the Late Filed Claims were filed after the General Bar Date as the deadline established by the Court for filing proofs of claim. Accordingly, the Debtor seeks entry of an order disallowing the Late Filed Claims in their entirety as untimely filed as set forth in Exhibit A to the Proposed Order.

12. Failure to reduce the Late Filed Claims will result in the applicable claimants receiving an unwarranted recovery against the Debtor's estate, to the detriment of other creditors in this case. Accordingly, the Debtor hereby objects to the Late Filed Claims and requests entry of an order disallowing each of the Late Filed Claims as set forth in Exhibit A to the Proposed Order.

RESERVATION OF RIGHTS

13. The Debtor reserves the right to amend, modify, or supplement this Objection in accordance with Local Bankruptcy Rule 3007-1.

14. Moreover, should the grounds of objection stated in this Objection be dismissed, overruled, or withdrawn or should the claimants submit additional information supporting their respective claims, the Debtor reserves the right to object further to the Late Filed Claims on any non-substantive or substantive grounds in the future in accordance with Local Bankruptcy Rule 3007-1.

COMPLIANCE WITH LOCAL RULE 3007-1

15. The Debtor, by and through its undersigned counsel, states that this Objection complies with Local Bankruptcy Rule 3007-1. To the extent this Objection does not comply in all

respects with the requirements of Local Bankruptcy Rule 3007-1, the undersigned believes such deviations are not material and respectfully requests that any such requirement be waived.

CONCLUSION

WHEREFORE, the Debtor respectfully requests that the Court enter the Proposed Order, attached hereto as **Exhibit 1**, disallowing the Late Filed Claims in their entirety as untimely filed and granting such further relief as is just and proper.

4. any supporting documentation, to the extent it was not included with the proof of claim previously filed with the clerk or claims agent, upon which the party will rely to support the basis for and amounts asserted in the proof of claim; and
5. the name, address, telephone number, email address and fax number of the person(s) (which may be the claimant or the claimant's legal representative) with whom counsel for the Debtor should communicate with respect to the claim or the First Omnibus Objection and who possesses authority to reconcile, settle, or otherwise resolve the objection to the disputed claim on behalf of the claimant.

Only a Response made in writing and timely filed and received will be considered by the Court at the Hearing.

2. Pursuant to Bankruptcy Code sections 105(a) and 502(b) and Bankruptcy Rule 3007, the Late Filed Claims identified on **Exhibit A** attached hereto are disallowed in their entirety as untimely filed.

3. The Debtor, Omni, and the Clerk of this Court are authorized to take all actions necessary or appropriate to give effect to this Order.

4. Each of the Late Filed Claims and the objections by the Debtor to such Claims, as set forth on **Exhibit A** hereto, constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014 and Local Rule 3007-1. This Order shall be deemed a separate Order with respect to each such Late Filed Claim. Any stay of this Order pending appeal by any claimants whose Late Filed Claims are subject to this Order shall only apply to the contested matter which involves such claimant and shall not act to stay the applicability and/or finality of this Order with respect to the other contested matters listed in the Objection or this Order.

5. Notwithstanding the relief granted in this Order or any actions taken pursuant to such relief, nothing in this Order shall be deemed: (a) an admission as to the validity of any particular claim against the Debtor; (b) a waiver of the Debtor's rights to dispute any particular claim on any grounds; (c) a promise or requirement to pay any particular claim; (d) an implication or admission that any particular claim is of a type specified or defined in the Objection; or (e) a waiver or limitation of the Debtor's rights under the Bankruptcy Code or any other applicable law.

6. This Court shall retain jurisdiction to hear and determine all matters related to and/or arising from the implementation and/or interpretation of this Order.

7. Notwithstanding any Bankruptcy Rule to the contrary, this Order shall take effect immediately upon entry.

**DECLARATION OF BRIAN AYERS IN SUPPORT OF THE DEBTOR'S FIRST

I, Brian Ayers, hereby declare under penalty of perjury, pursuant to section 1746 of title 28 of the United States Code, as follows:

1. I am the financial advisor to Solid Financial Technologies, Inc. (the “Debtor”) and a Managing Director of Rock Creek Advisors LLC (“Rock Creek”), a financial services firm that works with companies and their investors, shareholders, directors, lenders and other relevant constituents to help companies maximize their true potential. Rock Creek has expertise in turnarounds, assignments for the benefit of creditors, financial advisory services, and liquidations. At Rock Creek, I focus primarily on management consulting and financial restructuring, specializing in liquidity management, financial strategic planning, and implementation of financial strategies for corporate turnarounds and restructurings. I have more than 20 years of experience in a wide variety of industries, including retail, transportation and logistics, manufacturing, construction, healthcare, and bio-tech. I am a Certified Insolvency and Restructuring Advisor and

a Certified Turnaround Professional. In March 2025, I began overseeing the Rock Creek team engaged by the Debtor. In that role, I have become familiar with the Debtor's business and financial affairs.

2. I submit this declaration (the "Declaration") in support of the *Debtor's First Omnibus Objection to Late Filed Claims Pursuant to Section 502 of the Bankruptcy Code and Rule 3007 of the Federal Rules of Bankruptcy Procedure (Non-Substantive Objection)* (the "Objection")² filed contemporaneously herewith.

3. All facts set forth in this Declaration are based on: (a) my personal knowledge; (b) my discussions with the Debtor's representatives, other members of the Rock Creek team, or other parties in interest; (c) information supplied to me by members of the Debtor's management or other professionals; (d) information learned from my review of the relevant documents; and (e) my experience and knowledge of the Debtor's operations and financial condition.

4. I am not being specifically compensated for this testimony other than through payments received by Rock Creek as a professional retained by the Debtor in its Chapter 11 Case. If called as a witness, I could and would testify to the facts set forth in this Declaration. I am authorized to submit the Declaration on behalf of the Debtor.

5. I have reviewed the Late Filed Claims identified on Exhibit A annexed to the Proposed Order filed with the Objection.

6. To the best of my knowledge and belief, and based on the information and records available to me, each Late Filed Claim listed on Exhibit A to the Proposed Order was filed after the applicable General Bar Date. The Debtor's records reflect that, except for Tolomeo Bank International, Corp. ("Tolomeo International"), each holder of a Late Filed Claim was timely

served with the Bar Date Notice. While the Bar Date Notice's Affidavit of Service reflects that Tolomeo Bank Ltd was served with the Bar Date Notice and technically not Tolomeo International, both Tolomeo parties are represented by the same counsel in the underlying litigation (and the same counsel filed each of the Tolomeo parties' claims in this Chapter 11 Case). Additionally, Tolomeo International's counsel, who filed Tolomeo International's claim in this Chapter 11 Case and represents Tolomeo International in litigation underlying its claim, was timely served with a copy of the Bar Date Notice via email and first-class mail for four other parties represented by the same counsel in the underlying litigation, including Tolomeo Bank Ltd. *See* Affidavit of Service, at 3 (service on the Sanchez/LRV firm on behalf of Crossbarfx Ltd), 7 (service on the Sanchez/LRV firm on behalf of Tolomeo Bank Ltd, Vauban Bank Int'l Corp and Vauban Int'l Bank Corp). Therefore, Tolomeo International should be deemed to be timely served with, and bound by, the Bar Date Notice.

7. Based upon my personal knowledge, my familiarity with the processing and reconciliation of the Late Filed Claims, or my review of relevant documents, I believe that granting the relief requested in the Objection is in the best interests of the Debtor, its estates, and its creditors.

8. The undersigned certifies that the undersigned has reviewed the requirements of Local Rule 3007-1 and that the Objection substantially complies with that Local Rule. To the extent that the Objection does not comply in all respects with the requirements of Local Rule 3007-1, I believe that such deviations are not material and respectfully requests that any such requirement be waived.

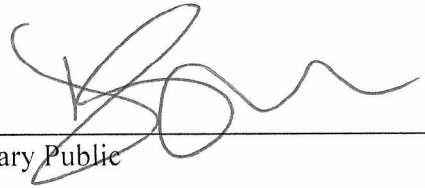

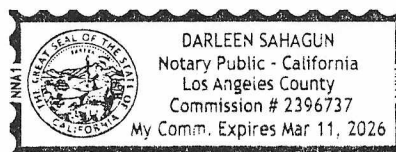
