THIS MATTER having been opened to the court upon the first interim application of K&L Gates LLP for allowance of compensation and reimbursement of expenses; and the court having considered the application and any objections thereto; and notice was given to all parties required to be served in the Debtor's chapter 11 case; and for good cause shown; it is hereby

ORDERED as follows:

1. The First Interim Fee Application is granted as provided herein.
2. K&L Gates LLP be and hereby is allowed and awarded first interim compensation for services rendered to the Debtor in the amount of \$210,848.50 and reimbursement of expenses for costs incurred in the amount of \$2,135.34.
3. The Debtor is authorized to pay the amounts awarded herein to K&L Gates LLP on an interim basis without further notice to creditors or order of the Court.
