NOTICE OF SATISFACTION OF CLAIMS

PECF USS Intermediate Holding II Corporation's chapter 11 case was previously jointly administered under the case of United Site Services, Inc., Case No. 25-23630 (MBK). The above-captioned reorganized debtor (the “**Reorganized Debtor**” and, together with its affiliated former debtors and their successors, as applicable, the “**Reorganized Debtors**” or “**USS**”), pursuant to the *Chapter 11 Complex Case Management Order* [Dkt. No. 117] and the *General Order Governing Chapter 11 Complex Case Procedures*, hereby files this notice (the “**Notice**”) identifying certain claims filed against the Reorganized Debtors’ estates that have been resolved and satisfied during the Reorganized Debtors’ chapter 11 cases (the “**Satisfied Claims**”). A list of the Satisfied Claims is attached hereto as **Exhibit A**.

You should locate your reference number or claim number and your Satisfied Claim(s) on Exhibit A attached hereto. Please take notice that your Satisfied Claim(s) may be expunged from the claims register and you shall not be treated as a creditor with respect to such Satisfied Claim for purposes of distribution as a result of this Notice. Therefore, please read this notice very carefully and discuss it with your attorney. If you do not have an attorney, you may wish to consult one.

BACKGROUND

1. On December 29, 2025 (the “**Petition Date**”), each Debtor commenced a case under chapter 11 of the Bankruptcy Code (collectively, the “**Chapter 11 Cases**”) by filing a voluntary petition for relief. These were prepackaged cases commenced for the purpose of implementing a comprehensive restructuring in accordance with the terms of a restructuring support agreement. The Debtors commenced solicitation of votes on the *Joint Prepackaged Plan of Reorganization of United Site Services, Inc. and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code* [Dkt. No. 16] (as subsequently amended, modified, supplemented, and confirmed, the “**Plan of Reorganization**”) reflecting the terms of the restructuring support agreement prior to commencing these Chapter 11 Cases, and filed that Plan of Reorganization on the Petition Date.

2. On February 27, 2026, the Court entered the *Order (I) Approving the Adequacy of the Disclosure Statement and (II) Confirming the Second Amended Joint Prepackaged Plan of Reorganization of United Site Services, Inc. and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code* [Dkt. No. 344].

3. On March 3, 2026, the Effective Date (as defined in the Plan of Reorganization) occurred. *See Notice of (I) Entry of an Order Approving the Adequacy of the Disclosure Statement and Confirming the Second Amended Joint Prepackaged Plan of Reorganization of United Site Services, Inc. and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code and (II) Occurrence of Effective Date* [Dkt. No. 384].

4. On April 16, 2026, the Court entered the *Final Decree Closing Certain of the Chapter 11 Cases* [Dkt. No. 454], closing the Chapter 11 Cases of the Reorganized Debtors, other than Reorganized Debtor PECF USS Intermediate Holding II Corporation. All remaining matters, including claims reconciliation with respect to claims against any Reorganized Debtor, are to be administered in the case of Reorganized Debtor PECF USS Intermediate Holding II Corporation.

5. For further information about USS, its business operations, assets and capital structure, and the circumstances that led to the filing of the Chapter 11 Cases, USS refers to the *Declaration of Chris Kelly in Support of Chapter 11 Petitions and First Day Motions of United Site Services, Inc. et al.* [Dkt. No. 15], filed on December 29, 2025.

SATISFIED CLAIMS

6. The Reorganized Debtor is seeking to expunge your Satisfied Claim(s) listed on Exhibit A hereto on the grounds that such Satisfied Claim(s) have been satisfied in full according to the Reorganized Debtors' books and records. No further distributions from the Reorganized Debtors will be required on account of amounts asserted as claims in connection with the Satisfied Claims. The Reorganized Debtor therefore intends to cause a notation to be made on the Reorganized Debtors' register of claims, prepared by Verita Global, the Court-appointed noticing and claims agent in the Chapter 11 Cases, indicating that the Satisfied Claims have been previously satisfied or otherwise require no further distribution. A copy of this Notice has been provided to counsel for each of the claimants listed on Exhibit A hereto.

7. All documents filed in the Chapter 11 Cases may be obtained free of charge by visiting the website of Verita Global at www.veritaglobal.net/USS. You may also obtain copies of pleadings by visiting the Bankruptcy Court's website at <https://www.njb.uscourts.gov/> in accordance with the procedures and fees set forth on that website.

RESERVATION OF RIGHTS

8. Nothing in this Notice shall be deemed to constitute a waiver of any rights of the Reorganized Debtors or any other party in interest to dispute any claims, assert counterclaims, exercise rights of offset or recoupment, raise defenses, object to any claims on any grounds not previously raised in an objection (unless the Court has allowed the claim or ordered otherwise), or seek to estimate any claim at a later date. Affected parties will be provided appropriate notice thereof at such time.
