**ORDER GRANTING THE FIRST AND FINAL FEE APPLICATION AND
SUPPLEMENT FILED BY QUINN EMANUEL URQUHART & SULLIVAN, LLP**

THIS MATTER came before the Court on November 17, 2025, at 9:30 a.m. (the “Hearing”), upon Quinn Emanuel Urquhart & Sullivan, LLP’s First and Final Fee Application of

Quinn Emanuel Urquhart & Sullivan, LLP for the Period June 30, 2025, through October 17, 2025 (Docket No. 232), the Supplement to the First and Final Fee Application of Quinn Emanuel Urquhart & Sullivan, LLP for the Period June 30, 2025, through October 17, 2025 (Docket No. 362), and the Notice of Filing Quinn Emanuel Urquhart & Sullivan, LLP's Actual Fees and Costs Through Confirmation (Docket No. 419) (together, the "Application") filed by Quinn Emanuel Urquhart & Sullivan, LLP ("Quinn Emanuel"). The court finds that it has jurisdiction over this matter pursuant to 28 U.S.C. § 1334, that the Application was properly filed and served, and that this is a core proceeding pursuant to 28 U.S.C. § 157(b). It is hereby

ORDERED, that Quinn Emanuel Urquhart & Sullivan, LLP is hereby allowed final compensation for actual professional fees billed in the amount of \$176,385.00 incurred from June 30, 2025, through August 31, 2025; it is further

ORDERED, that Quinn Emanuel Urquhart & Sullivan, LLP is hereby allowed final compensation for actual professional fees billed in the amount of \$618,440.00 incurred from September 1, 2025, through October 31, 2025; it is further

ORDERED, that Quinn Emanuel Urquhart & Sullivan, LLP is hereby allowed \$88,538.00 in actual fees for the period from November 1, 2025, through November 17, 2025; it is further

ORDERED, that Quinn Emanuel Urquhart & Sullivan, LLP is hereby allowed final reimbursement of actual and necessary expenses in the amount of \$3,492.85 incurred from June 30, 2025, through August 31, 2025; it is further

ORDERED, that Quinn Emanuel Urquhart & Sullivan, LLP is hereby allowed final reimbursement of expenses in the amount of \$4,051.29 incurred from September 1, 2025, through October 31, 2025; it is further

ORDERED, that Quinn Emanuel Urquhart & Sullivan, LLP is hereby allowed \$1,859.87 in actual expenses for the period from November 1, 2025, through November 17, 2025; it is further

ORDERED, that the Debtors are authorized to pay to Quinn Emanuel Urquhart & Sullivan, LLP, total fees in the amount of \$883,363.00 and total expenses in the amount of \$9,404.01.
