PLEASE TAKE NOTICE that on March 25, 2026, the above-captioned debtors and debtors in possession (collectively, the “Debtors”) filed the *Debtors’ Motion for Entry of (A) an Order (I) Approving Bidding Procedures for the Sale of Substantially All of Lurin Real Estate Holdings XXI, LLC, Lurin Real Estate Holdings XXVIII, LLC, and Lurin Real Estate Holdings XXXIII, LLC’s Assets, (II) Approving Bid Protections, (III) Scheduling Certain Dates with Respect Thereto, (IV) Approving the Form and Manner of Notice Thereof, (V) Approving Contract Assumption and Assignment Procedures, (VI) Authorizing Designation of Stalking Horse Bidders, and (VII) Granting Related Relief* [Docket No. 74] (the “Motion”).

PLEASE TAKE FURTHER NOTICE that the Order provided July 2, 2026, as the deadline to designate a stalking horse bidder (the "Designation Deadline") for both Lurin Real Estate Holdings XXVIII, LLC (the "Aria") and Lurin Real Estate Holdings XXXIII, LLC (the "Emory").

PLEASE TAKE FURTHER NOTICE that the Order provided July 9, 2026, at 5:00 p.m. (prevailing Central Time) as the deadline to object to designation of any stalking horse bidder or grant of bid protections (the "Designation Objection Deadline") for both the Aria and the Emory.

PLEASE TAKE FURTHER NOTICE that, for both the Aria and the Emory, the Designation Deadline is extended to **July 9, 2026**, and the Designation Objection Deadline is extended to **July 16, 2026, at 5:00 p.m. (prevailing Central Time)**. All other deadlines in the Order remain unaffected.
