The Court has considered the *Third Interim and Final Fee Application of Latham & Watkins LLP for Compensation for Services Rendered and for Reimbursement of Expenses Incurred as Bankruptcy Counsel to the Debtors for the (I) Interim Period from September 1, 2024 Through and Including October 1, 2024 and (II) Final Period from February 15, 2024 Through and Including October 1, 2024* (the “Application”) filed by Latham & Watkins LLP (the “Applicant”). The Court orders:

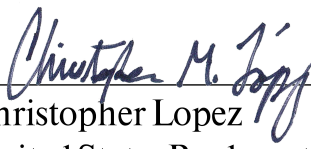
1. Applicant is allowed compensation and reimbursement of expenses in the amount of \$444,951.06 for the period from September 1, 2024, through and including October 1, 2024.
