**ORDER AUTHORIZING THE JOINT ADMINISTRATION OF THE DEBTORS’
CHAPTER 11 CASES AND GRANTING RELATED RELIEF**

Upon the motion (the “**Motion**”)¹ filed by the above-captioned debtors and debtors in possession (collectively, the “**Debtors**”) for entry of an order (this “**Order**”), pursuant to Bankruptcy Rule 1015(b) and Bankruptcy Local Rule 1015-1, authorizing the joint administration

of their Chapter 11 Cases, all as more fully set forth in the Motion; and this Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. § 1334; and consideration of the Motion and the requested relief being a core proceeding pursuant to 28 U.S.C. § 157(b); and it appearing that venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion having been provided; and such notice having been adequate and appropriate under the circumstances, and it appearing that no other or further notice need be provided; and this Court having reviewed the Motion; and all objections, if any, to the relief requested in the Motion having been withdrawn, resolved, or overruled; and upon consideration of the Motion and First Day Declaration; and the Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and it appearing that the relief requested in the Motion is in the best interests of the best interests of the Debtors, their respective estates, creditors, and all parties in interest; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor,

IT IS HEREBY ORDERED THAT:

1. The Motion is GRANTED to the extent set forth herein.
2. The Chapter 11 Cases are consolidated for procedural purposes only and shall be jointly administered in accordance with the provisions of sections 105(a) and 342(c) of the Bankruptcy Code, Bankruptcy Rule 1015(b), and Local Rules 1015-1, 1075-1, and 9013-1.
3. Additionally, the following items are ordered:
 - a. One disclosure statement and plan of reorganization may be filed for all of the cases by any plan proponent.
 - b. Parties may request joint hearings on matters pending in any of the jointly administered cases.

c. Other: see below.

4. The Court shall maintain one file and one docket for all of these Chapter 11 Cases, under the lead case of Synergex Legacy Holdings, LLC. All pleadings filed in these Chapter 11 Cases shall bear a consolidated caption in the following form:

5. Nothing contained in this Order shall be deemed or construed as directing or otherwise affecting the substantive consolidation of any of the above-captioned cases, the Debtors, or the Debtors' estates.

6. The foregoing caption satisfies the requirements set forth in section 342(c)(1) of the Bankruptcy Code.

7. The Clerk of Court shall make docket entries, substantially in the form of the following, on the docket of each of the Chapter 11 Cases to reflect the joint administration:

An order has been entered in this case in accordance with Rule 1015(b) of the Federal Rules of Bankruptcy Procedure and Rule 1015-1 of the Local Bankruptcy Rules for the United States Bankruptcy Court for the Southern District of Texas directing the joint administration of the chapter 11 cases of SynergexX Legacy Holdings, LLC. **All further pleadings and other papers shall be filed in, and all further docket entries shall be made in Case No. 26-90644.**

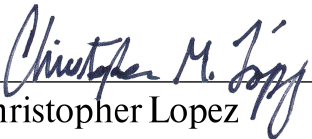
