PLEASE TAKE NOTICE that, on April 15, 2026, the United States Bankruptcy Court for the District of Delaware (the “**Bankruptcy Court**”) entered the *Order (I) Approving Proposed Disclosure Statement, (II) Establishing Solicitation and Voting Procedures with Respect to Proposed Joint Chapter 11 Plan, (III) Scheduling Confirmation Hearing, (IV) Establishing Notice and Objection Procedures for Confirmation of Proposed Joint Chapter 11 Plan, and (V) Granting Related Relief* [Docket No. 398] (the “**Solicitation Procedures Order**”) approving the *Disclosure Statement for Joint Chapter 11 Plan of Liquidation of Valves and Controls US, Inc. and Official Committee of Unsecured Creditors* [Docket No. 403] for the *Joint Chapter 11 Plan of Liquidation of Valves and Controls US, Inc. and Official Committee of Unsecured Creditors* [Docket No. 402] (the “**Plan**”).² Pursuant to paragraphs 42 and 43 of the Solicitation Procedures Order, the Debtor is authorized to adjourn or reschedule the Confirmation Hearing and extend related dates and deadlines with respect to the Plan without further order of the Bankruptcy Court, upon notice filed with the Bankruptcy Court.
